- 6. This research is your preparation for the completion of an in-class essay on this content, which will be completed under test conditions. **Notes are not to be used during completion of the in-class task.**

Your notes must be detailed. These will be your set of class notes on this syllabus dot point and will be the notes from which you will study in preparation for the in-class essay on which you will be assessed. They will also be your notes for this section of the syllabus.
